8. If Bidder wish to Submit the bid security(Bank Guarantee) in the form of cash ,bidder has to deposit cash in Dharauti Account no **1230000004 GE** of Mellekh Rural Municipality Achham at Century Bank,Mellekh Branch,Achham and Submit Bank Deposit Voucher along with a Bid.
9. Bidders are required to specify the total price of the Bid in the Letter of Bid or the Bid Price in the Bill of Quantities. Failure to specify the total price of the Bid in the Letter of Bid or the Bill of Quantities shall be ground for declaring the bid non-responsive.
10. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
